## Beware of Fraudulent Activities

### Impersonating Guotai Junan International

June 30, 2026

Dear Valued Clients & Investors,

Guotai Junan International Holdings Limited ("GTJAI" / "the Company") and its affiliates (collectively "the Group") have recently identified instances of fraudsters impersonating the Company or the Group to conduct investment scams.

Common fraudulent tactics include:

- **Identity Impersonation:** Contacting investors by forging the Group's employee business cards, trading platforms, or official websites.
- **Defrauding Funds:** Inducing clients to transfer funds into personal or third-party bank accounts belonging to fraudsters.
- **Acquiring Personal Data:** Requesting clients to fill out forged documents or electronic forms to collect sensitive personal information.

The Company urges all investors and clients to remain highly vigilant when encountering suspicious messages. Please pay attention to the following important information and ensure you verify information or conduct transactions through our Official Contact Channels:

- **Verify Identity:** If anyone claiming to be an employee of the Group requests personal data or induces you to transfer funds, please contact the Group immediately for verification or report the matter to local law enforcement.
- **Legal Rights:** The Group reserves the right to pursue legal action against any fraudulent activities that damage the Group's reputation or mislead clients.
