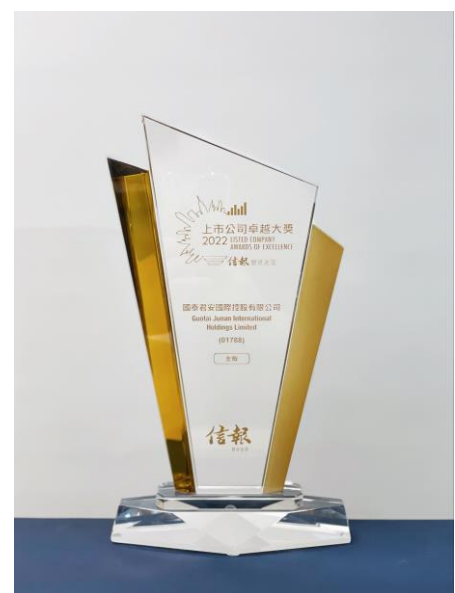




GTJAI Received "2022 Listed Company Awards of Excellence" from Hong Kong Economic Journal
