❖ **Investment Objective & Strategy**

The Sub-Fund seeks to achieve its objective by investing primarily (at least 70% of its NAV) in a portfolio of mainly USD, EUR and HKD denominated investment grade debt securities issued or traded in the global debt securities markets. The Sub-Fund’s aggregate investments in below investment grade debt securities and unrated debt securities will be limited to 30% of its Net Asset Value.

❖ **Portfolio Manager’s Perspective**

In view of the uncertainty of relevant policies after the new U.S. administration took office, the overall strategy of the portfolio is stable, focusing on the balance of different sectors, avoiding a single bet on duration, abiding by investment-grade targets, strictly controlling credit risks and fluctuations, avoiding sinking qualifications, grasping the allocation window at the beginning of the year, selecting high-quality targets, and choosing opportunities to improve returns.

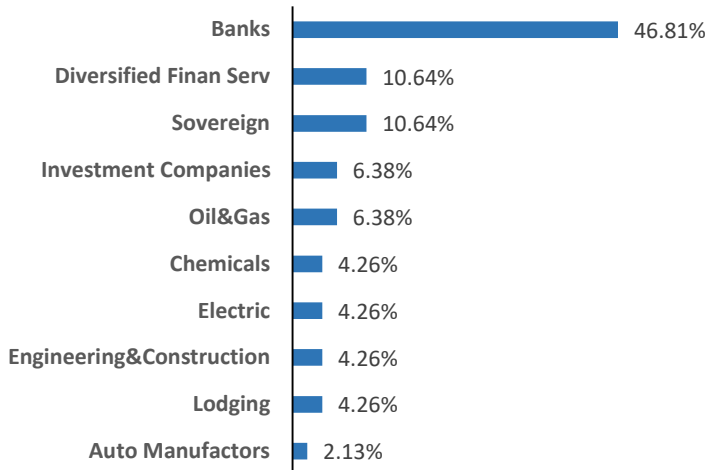

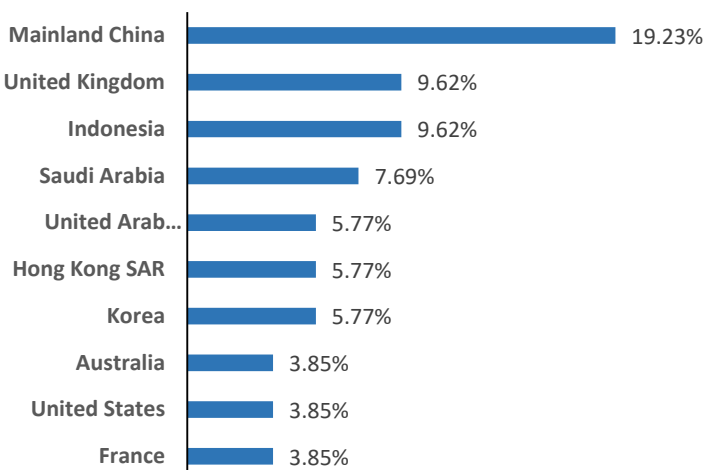

## ❖ Top 10 Sector Exposure



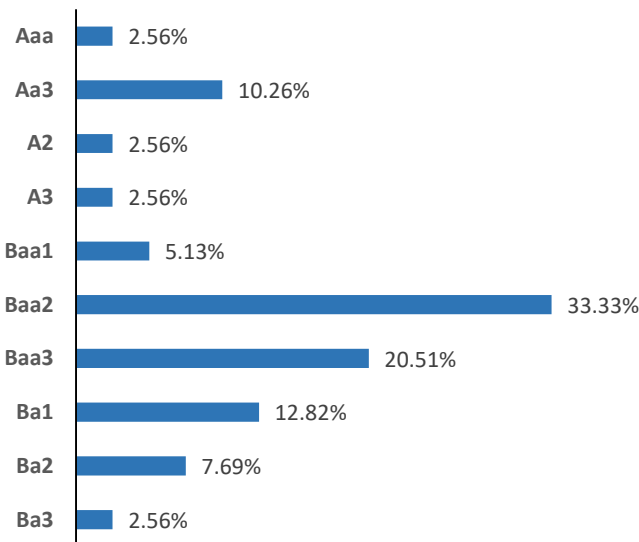

## ❖ Top 10 Geographical Exposure



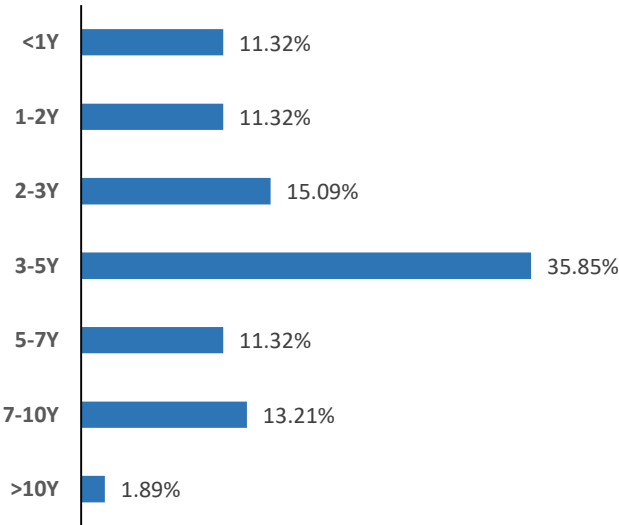
