❖ Investment Objective & Strategy

The Sub-Fund seeks to achieve its objective by investing primarily (at least 70% of its NAV) in a portfolio of mainly USD, EUR and HKD denominated investment grade debt securities issued or traded in the global debt securities markets. The Sub-Fund’s aggregate investments in below investment grade debt securities and unrated debt securities will be limited to 30% of its Net Asset Value.

The market will continue to evaluate Trump's actions on tariffs and deficit reduction, as well as their impact on future economic growth and Treasury bond duration. The portfolio will continue to rely on credit research, maintain a relatively low duration, and focus on stable interest income, aiming to avoid significant portfolio fluctuations.

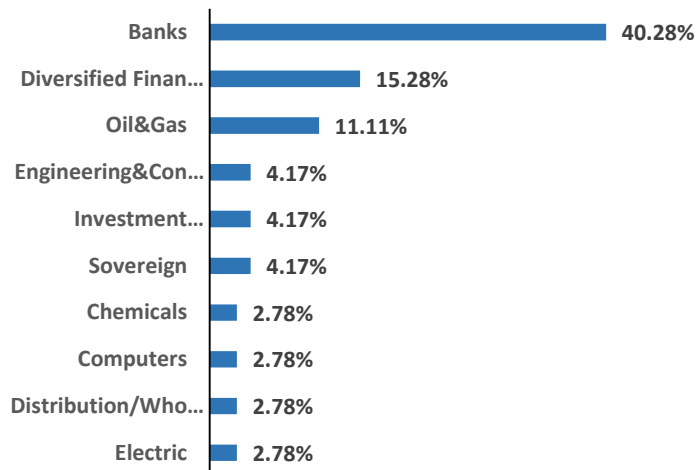

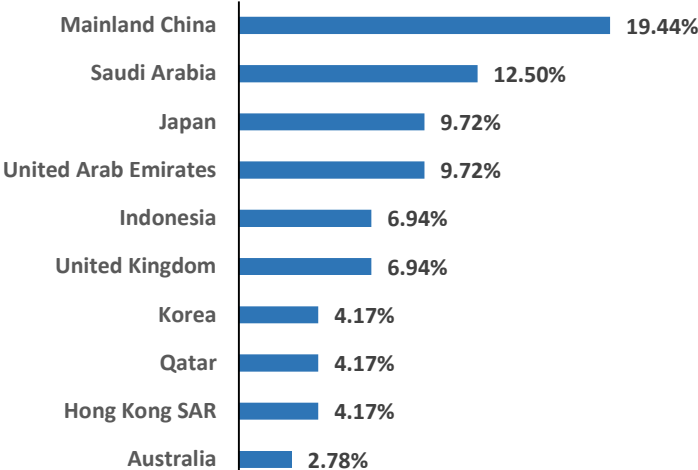

❖ Top 10 Sector Exposure



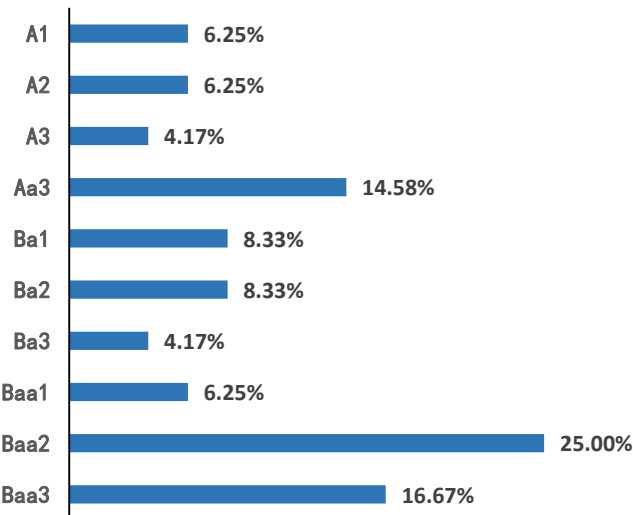

❖ Top 10 Geographical Exposure



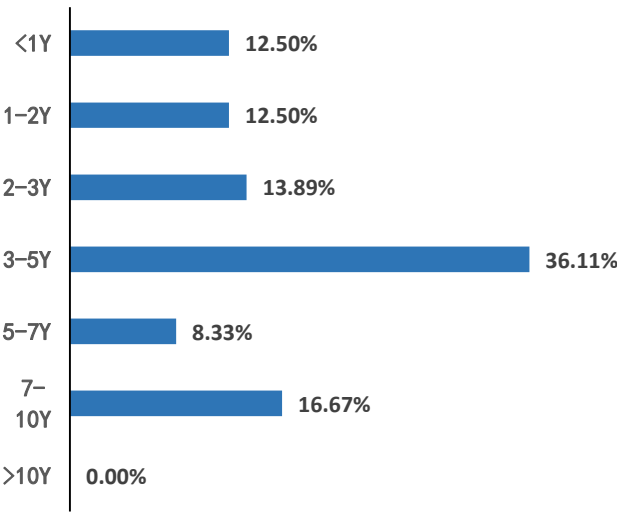
