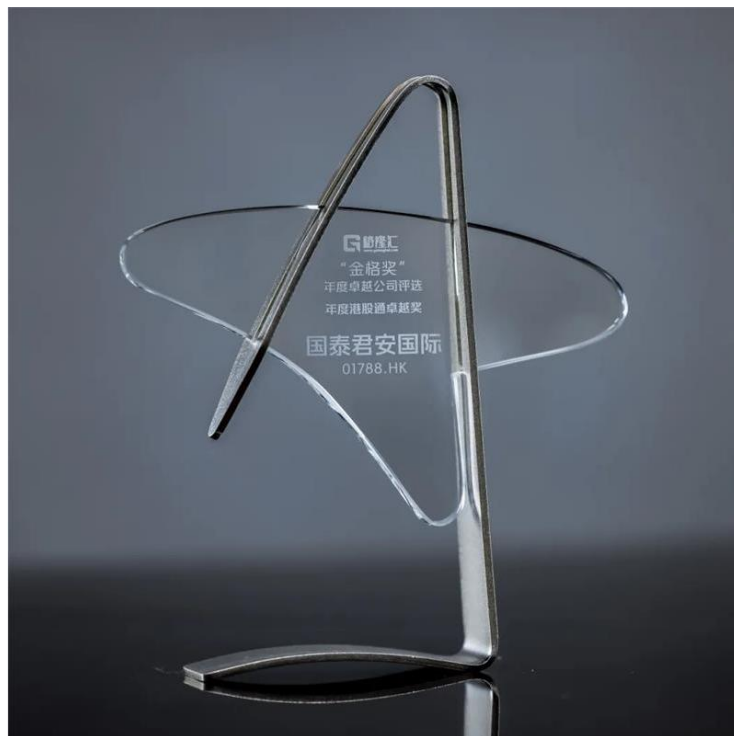




# GTJAI Wins Gelonghui “Golden Award · Annual Hong Kong Stock Connect Excellence Award”
