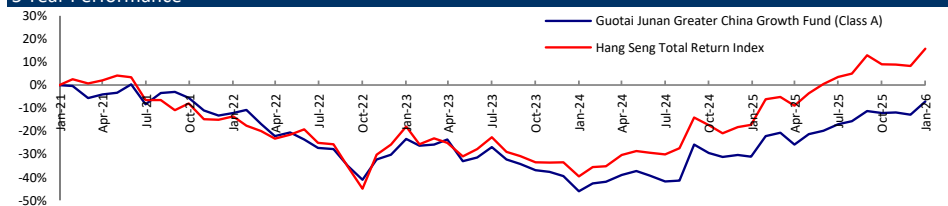

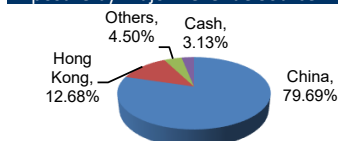

## Market Outlook and Investment Strategy

Building on the strong performance of 2025, the Hong Kong stock market delivered a robust start to 2026. The Hang Seng Index rose 6.85% for the month to close at 27,387.11 (intraday high of 28,056.10 on 29 January, marking a 4.5-year high). The Hang Seng Tech Index advanced 3.67% to close at 5,718.18. The rally was primarily driven by sustained Southbound inflows, short-term strengthening of CNY against the USD, domestic policy tailwinds, and a more accommodative global liquidity environment. Market activity was notably brisk, with average daily turnover exceeding HK\$240 billion. The Southbound recorded a strong net inflow of approximately HK\$69 billion in January — roughly three times the level in December 2025 — underscoring mainland investors' continued enthusiasm for Hong Kong-listed assets. Inflows were mainly concentrated in the technology, financials and consumer sectors, with major beneficiaries including technology leaders such as Tencent and Xiaomi, as well as high-dividend names such as China Life Insurance and China Construction Bank. Sector performance was differentiated. Within the Hang Seng Industry Classification Indices, raw materials, energy and property & construction led the gains. Consumer discretionary, healthcare and financials also posted solid return, while telecommunications was relatively subdued. Sub-sectors such as semiconductors and non-ferrous metals outperformed significantly, supported by ongoing momentum in the AI supply chain and rising international gold prices.

Domestically, the directives of the Central Economic Work Conference continued to be implemented. The launch of the 15th Five-Year Plan placed strong emphasis on new quality productive forces, including AI, high-end semiconductors and humanoid robotics, with policy support steadily materializing. Export resilience remained intact, while further refinements to consumption and property policies helped bolster market confidence. The 2026 GDP growth target is widely expected to be set within a reasonable range. Internationally, US economic data stabilized. The Fed maintained its rate-cutting cycle, although market expectations for a slower pace of easing intensified. The US dollar index once retreated to around 96, improving global liquidity conditions and supporting emerging-market assets. Geopolitical risks fluctuated but were largely priced in by the market; the phased easing of US–China relations also provided some support to risk appetite.

Overall, the Hong Kong stock market recorded a strong start thanks to domestic policy supports, persistent Southbound inflows and CNYUSD strength. Market vitality remained robust and IPO fundraising momentum continued, with full-year 2026 fundraising projected at HK\$320–350 billion. Looking ahead, taking into account the abovementioned factors together with foreseeable catalysts, the Hong Kong market is expected to maintain a volatile but upward trend through the first quarter. From a long-term perspective, improvements in China's economic fundamentals will not materialize overnight, while structural opportunities — particularly in areas like AI — are expected to emerge in Hong Kong equities. We remain cautiously optimistic on the long-term development of the Chinese economy.
