❖ Investment Objective & Strategy

The Sub-Fund seeks to achieve its objective by investing primarily (at least 70% of its NAV) in a portfolio of mainly USD, EUR and HKD denominated investment grade debt securities issued or traded in the global debt securities markets. The Sub-Fund’s aggregate investments in below investment grade debt securities and unrated debt securities will be limited to 30% of its Net Asset Value.

❖ Portfolio Manager’s Perspective

As geopolitics keeps energy prices and uncertainty elevated, a prolonged Strait of Hormuz disruption is evolving from a “flow shock” into a stock-depletion problem, with the US last to feel physical shortages. If disruption persists into mid-April an outcome that would lift headline inflation, materially squeeze consumer purchasing power, and potentially weaken the labor market, increasing the case for Fed easing.

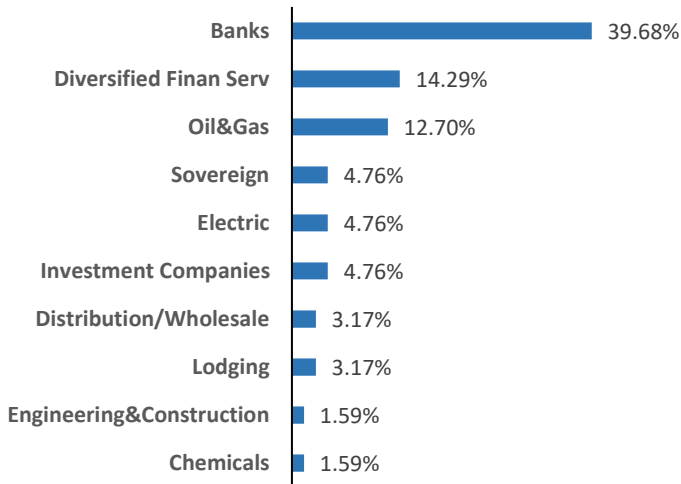

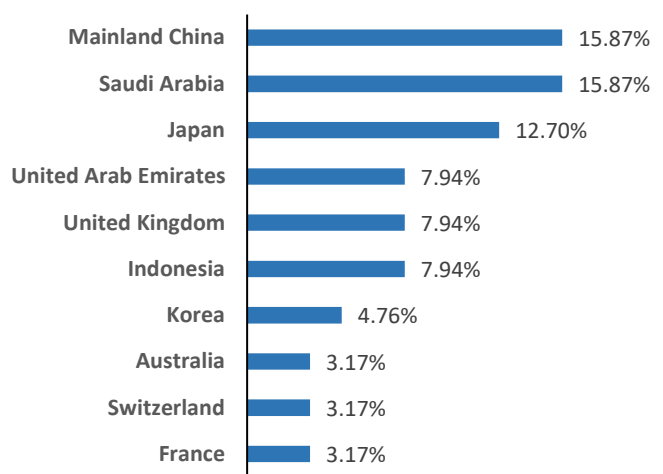

❖ Top 10 Sector Exposure



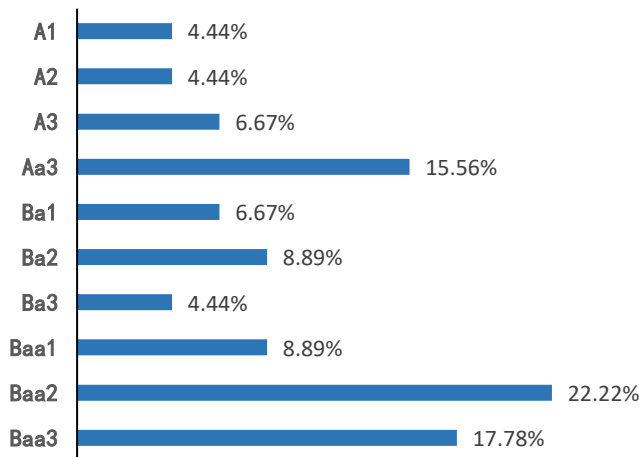

❖ Top 10 Geographical Exposure



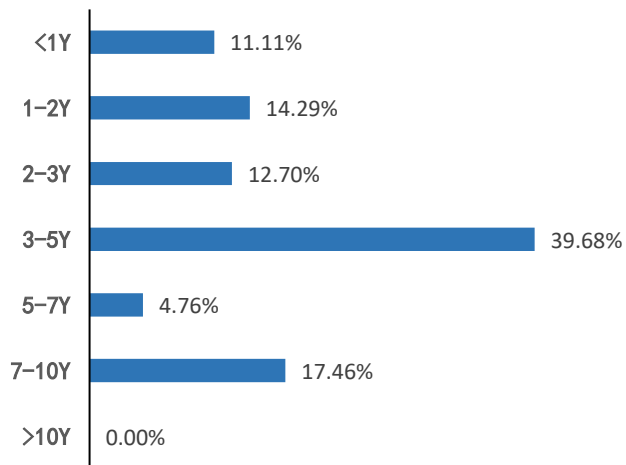
