Risk Disclosure Statements 風險披露聲明

Internet Trading Execution Notification is a monitoring measure implemented by the Hong Kong Securities and Futures Commission Guidelines for Reducing and Mitigating Hacking Risks Associated with Internet Trading. By receiving promptly notification on trade execution, clients are allowed to understand the internet trading status of their trading accounts, in order to detect all potential unauthorized transactions in a timely manner, and take measures to reduce or mitigate hacking risks associated with internet trading, so to protect the trading account of clients. Client chooses to opt-out from internet trading execution notification, may fail to know or detect the account being hacked, unauthorized transactions or abnormal activities in time. Client acknowledges, understands and wholly be responsible for any disputes, losses, liabilities and risks involved in opt-out from internet trading execution notification.
